Chair Lisa Colbert called the meeting to order at 6:33 pm.

COMMISSIONERS ROLL CALL: Present: 4D01-Nancy Roth; 4D02-Renee Bowser; 4D03-Lisa Colbert; 4D04-Jamie Barden; 4D05-Krystal Branton; 4D06-Amy Hemingway. Quorum was present for all votes.

APPROVAL OF AGENDA: Comm. Bowser added an announcement about the PSA 403 April 19 meeting. Comm. Hemingway moved to approve the agenda with the one edit. Comm. Branton seconded. The commission unanimously approved the agenda as modified.

Comm. Roth moved to approve a resolution in support of Crown Bakery's zoning variance request. Comm. Bowser seconded. The commission unanimously approved the request.

Roth the point of contact on all matters regarding this. Comm. Hemingway seconded. The commission unanimously approved the resolution.

Comm. Roth moved to approve a resolution to protest S&G Wine & Liquors' liquor license renewal request; and to name Comm. Roth the point of contact on all matters regarding this. Comm. Bowser seconded. The commission unanimously approved the request.
